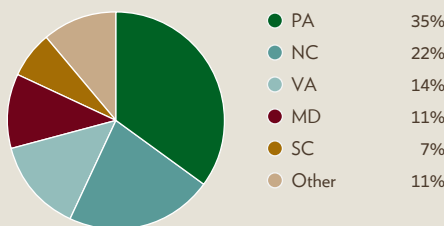
DISTRIBUTION

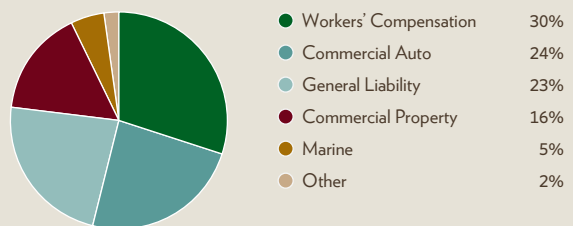
2010 PREMIUM DISTRIBUTION
