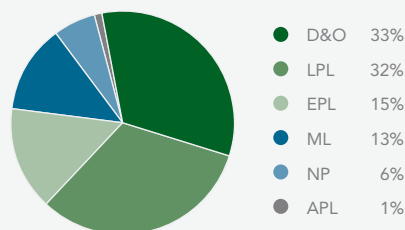

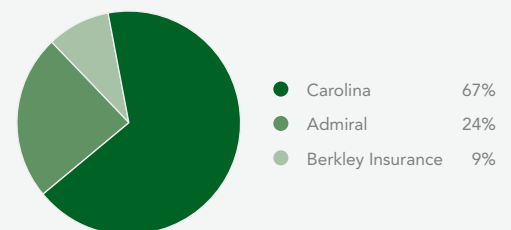
## FINANCIAL HIGHLIGHTS
